Notice of Intent will allow the city to apply for grants should a disaster happen. Notice of Intent will have an in kind match of \$4200.00 in preparing the plan. This cost would be for each entity, there will be five participating, and the total cost would be

\$21,000 for the plan to be written. This fee will be covered by keeping an account of all individuals that work on the plan. No actual monies should have to be paid. Mr. Wilson recommended that the city participate. Tolar was the only city not listed in the current plan.
